Subject: **HARDSHIP, BROKEN FAMILY, SUBSTITUTION AND LABOR QUOTA CASES FOR HAJJ 2014.**

In order to finalize the hardship, broken family, substitution and labor quota cases for Hajj 2014 the following committee has been approved by the competent authority of Ministry of Religious Affairs and Interfaith Harmony:-

2. The TORs of the said committee are:

- i) To get the applications properly assorted under various categories.
- ii) To evaluate the merit of petitions filed by intending pilgrims.
- iii) To recommend cases for inclusion or rejection.
- iv) To evolve the mechanism-modalities to process these cases.

3. The hardship, broken family, substitution and labour quota cases may include the following:-

Hardship Cases:

- i) Child-Newly born infant whose parents are going for Hajj and intend to carry their baby with them.
- ii) Applicant submitted application in time but bank forwarded it to the Ministry after due date and time or family members applied in different dates and time or due to bank mismanagement.
- iii) Person who intend to perform Hajj with his-her dependents including old parents.
- iv) The person who could not apply with his-her family but intends to join them now.
- v) Technical deficiency in travel document like lack of photo in passport-CNIC or any other case the committee considers is eligible for consideration.
- vi) The intending Hujjaj of the far flung-remote areas, who had no access to print and electronic media other means of communication.
- vii) Unsuccessful applicants of last two years and could not apply for Hajj 2014.
- viii) Those who not proceed on Hajj-2013 due to voluntary withdrawal or any other reason but did not take refund till announcement of Hajj Policy of Hajj 2014.

Broken Family:


- i) Lady is successful, whereas her mehram has been declared unsuccessful.
- ii) Husband who applied in time but due to some unavoidable reasons-social circumstances or non availability of CNIC-MRIP, his spouse could not submit Hajj application form.

Substitution Cases:

Applicant, who died or has become unable to proceed on Hajj due to unavoidable reasons, may nominate any of his-her relatives for substitution.

Labor quota:

Low paid-laborers who are fully funded by their Organization under Corporate Social Responsibility (CSR).
