

## EXPRESSION OF INTEREST

1. On the request of a special group, Ministry of Religious Affairs & Interfaith Harmony intends to organize a Short Duration Flight (SDF) through Hajj Group Organizers, for duration of 13-14 days for hajj 2015.
2. List of desirous HGOs will be finalized, announced by the Ministry of Religious Affairs & Interfaith Harmony.
3. Ministry of Religious Affairs & Interfaith Harmony is desirous to invite sealed quotations for provision of administrative facilities from quota holder HGOs having experience of handling such group for the following facilities.

Stay (Double bed Room)	<ul style="list-style-type: none"> <li>➤ 04 nights stay at Madinah Munawwarah in 3 or 4 star hotel in Markazia (01<sup>st</sup> Zulhijah to 04<sup>th</sup>/5<sup>th</sup> Zulhijah).</li> <li>➤ 07 nights stay in Makkah Mukarrammah in 3 or 4 or 5 star hotel within 400 meters from Haram(04<sup>th</sup>/5<sup>th</sup> Zulhijah to 14<sup>th</sup> Zulhijah)</li> <li>➤ 04 nights stay at Mina in Maktab No. 1-4 (08<sup>th</sup> Zulhijah-12<sup>th</sup> Zulhijah).</li> <li>➤ Extra bed will be provided in Madinah and Makkah accommodation on demand subject to deposit of its charges.</li> </ul>
II.	Transport	<ul style="list-style-type: none"> <li>➤ Post 2013 model buses from Madinah Airport to Hotel.</li> <li>➤ Post 2013 model buses for Madinah Ziaraat.</li> <li>➤ Post 2013 model buses for Madinah-Makkah which must be only from Naqaabah registered companies and have a valid Tasreeh to move on 5<sup>th</sup> Zulhijah.</li> <li>➤ Post 2013 model buses for Makkah-Mina-Arafat-Muzdalfa-Mina-Makkah and must have a valid tasreeh from the respectiveMaktab and concerned KSA authorities.</li> <li>➤ Post 2013 model buses for Makkah-Jeddah Airport.</li> </ul>
III.	Food	<ul style="list-style-type: none"> <li>➤ Full Board Buffet (03 dishes in breakfast, lunch, Dinner, which include at least one meat/chicken dish especially in lunch and dinner) in hotels in Madinah, Makkah and Mina.</li> </ul>
IV.	Air-travel	<ul style="list-style-type: none"> <li>➤ SDF will be arranged from Islamabad-Madinah and Jeddah-Islamabad sector by Ministry of Religious Affairs &amp; Interfaith Harmony. However, payment will be charged from the concerned HGO on actual basis.</li> </ul>

		Development Bank (IDB) or one of its authorized agent. ➤ Provision of give aways (Ahram/Abaya, Ahram Belt, Hand Bag) to pilgrims. ➤ Provision of at least 25 wheel chairs to the handicap/elderly pilgrims on their request.

7. Successful HGO is required to sign a written agreement with each pilgrim before departure to KSA for performance of Hajj and also sign the contract with MORA & IH for arrangements.
8. All interested HGOs are required to submit their quotations in the office of the undersigned on **Monday, 22<sup>nd</sup> June, 2015 at 1000hrs**. Quotations must be submitted along with bank draft of Rs.25,000/- (Non-Refundable) in favour of Pilgrims Welfare Fund, MORA & IH on a prescribed format in sealed envelope. Bids will be opened in presence of bidder on the same day at 1230hrs.
9. Incomplete bids will not be entertained.
