Dear Sir,

I am directed to say that Compulsory Hajj Dues, Service charges and Mohafiz Hajj Scheme to be received from the HGOs for Hajj 2016 are as under:

2. The HGOs may deposit CHD according to their flight schedule i.e. Pre/Post and Direct Madina so as to avoid refund at later stage. In case of any mis-statement, it would lead to major penalty i.e. black list or suspension of quota.

3. All Hajj Directorates are requested to receive bank drafts/pay orders in favour of "Ministry of Religious Affairs & Interfaith Harmony" on account of Compulsory Hajj Dues in Pak Rupees. Separate drafts/pay orders of service charges and Hujjaj Mohafiz Fund will also be received in Pak Rupees from the HGOs according to allocation of their Hajj quota for Hajj 2016 at the above mentioned rates and render their accounts along with drafts of CHD and Service Charges to this Ministry accordingly.
