Subject: **GUIDELINES FOR ISSUANCE OF NO MANAGEMENT DISPUTE CERTIFICATE.**

In compliance of orders of the Honorable Lahore High Court, Lahore in ICA No. 944 of 2015 titled Ahmed Ali Razzaqi vs FOP dated 1-6-2016, following guidelines/criteria are issued by this Ministry in consultation with SECP regarding issuance of a Certificate in respect of Hajj Group Organizers (HGOs):-

- a. Each HGO shall submit a proforma duly filled in to concerned Regional Registration Office of SECP. Format of the proforma is attached at Annexure-I
- b. Concerned SECP Regional Office shall verify the credential of HGO and incorporate its comments, if any, in the proforma.
- c. The HGO shall submit the above proforma duly verified by SECP within the due date/time so fixed by this Ministry.
