1. Accommodation

OPAP invites Expression of Interest (EOI) / Bids from the Building Owners / their Authorized Attorneys / Registered Accommodation Groups, who have valid 'Tasreehs' and are interested in renting out their buildings at Madinah-al-Munawarah for Pakistani hujjaj during Hajj Season-2019 A.D/1440 A.H. in line with the regulations issued by the Kingdom of Saudi Arabia for the Hajj 1440 A.H.

- a. The EOI / Bids shall be for 100% accommodation in Central Area / Markazia
- b. The accommodation groups must be registered with Ministry of Hajj, KSA, Moassassah Adillah Madinah-al-Munawarah and other relevant authorities as required under rules
- c. The bidder may also offer a good quality complete building in non markazia.

- The last date for submission of bids is **7th April, 2019, till 1100 hrs** and shall be opened on the same date at 1130 hrs in OPAP office, Pakistan House, Madinah-al-Munawarah, in the presence of the bidders or their representatives who may choose to attend.
