

Subject: **OFFER OF HAJJ BUSINESS FOR – 2017.**

In continuation to this Ministry's letter of even number dated 30<sup>th</sup> June, 2017, Ministry of Religious Affairs and Interfaith Harmony has allowed **102** more HGOs, after scrutiny of their credentials, for participation in Hajj Operation 2017. List of HGOs is attached for information of all concerned. These HGOs are required to select any two Hajj packages out of total 14 Hajj packages available on website of the Ministry for booking of Hujjaj by **18<sup>th</sup> July 2017**. The HGOs are further advised to upload following documents on HGOMIS and submit hard copy in concerned Directorate of Hajj on or before the above dead-line positively:-

- Hajj application forms of hujjaj
- Online filled in Summary Form
- Signed Service Provider Agreement – 2017 on stamp paper of Rs. 500 duly attested by Notary Public (original hard copy only)
- Proof of payment made to AO (PWF) on account of Service Charges
- Proof of transfer of Compulsory Hajj Dues (CHD) to respective IBAN.
- Proof of deposit of performance guarantee @ 5% (10% in case of new companies) of package in the form to bank/cash guarantee to AO(PWF) valid for one year.

2. It may be noted that the Ministry will not be responsible if any HGO becomes ineligible for hajj operation due to any reason or fails to book Hujjaj by the deadline i.e. 18<sup>th</sup> July 2017. (This Ministry's letter No.F.6(4)/2016-HGOs dated 7<sup>th</sup> July 2017 may be treated as withdrawn).
