INVITATION TO EXPRESSION OF INTEREST / BID

1. OPAP invites Expression of Interest (EOI) / Bids from the Building Owners / their Authorized Attorneys / Registered Accommodation Groups, who have valid 'Tasreehs' and are interested in renting out their buildings and / or beds at **Madinah-al-Munawarah** for Pakistani hujjaj during Hajj Season-2018 A.D/1439 A.H. in line with the regulations issued by the Kingdom of Saudi Arabia for the Hajj 1439 A.H.
 - a. The EOI / Bids shall be for 100% accommodation in Central Area / Markazia
 - b. The accommodation groups must be registered with Ministry of Hajj, KSA, Moassassah Adillah Madinah-al-Munawarah and other relevant authorities as required under rules
 2. OPAP also invites Expression of Interest (EOI) / Bids for provision of food and catering services to Pakistani hujjaj at their buildings in **Madinah-al-Munawarah** during Hajj Season 2018 A.D / 1439 A.H. directly from the Catering Companies.
 - a. The rates shall be offered for three meals per day as per prescribed menu
 - b. The catering company should be registered with the Ministry of Hajj, KSA, Amanah Madinah-al-Munawarah and other relevant authorities as required under the rules
 3. OPAP also invites Expression of Interest (EOI) / Bids for provision of food and catering services to 9,000 Pakistani hujjaj at their buildings in **Makkah-al-Mukarramah** during Hajj Season 2018 A.D / 1439 A.H. directly from the Catering Companies.
 - a. The rates shall be offered for three meals per day as per prescribed menu
 - b. The catering company should be registered with the Ministry of Hajj, KSA, Amanah Makkah-al-Mukarramah and other relevant authorities as required under the rules
- Only Saudi nationals being owners or legally authorized Saudi representative are advised to visit / submit EOI / applications, complete in all respect directly to OPAP, during working hours, i.e., 0900 hrs to 1600 hrs (Sunday to Thursday).
 - The Five/Four Star hotel owners / Groups offering these hotels, who are accommodating OPAP hujjaj in Madinah-al-Munawarah are also eligible to apply for the catering services in Madinah-al-Munawarah, subject to completion of all codal formalities and rules of regulations as applicable by the Ministry of KSA or any other relevant authority.
 - The last date for submission of bids is 11th March, 2018, till 1200 hrs and shall be opened on the same date at 1400 hrs in OPAP, Consulate General of Pakistan, Jeddah, in the presence of the bidders or their representatives who may choose to attend.
 - OPAP reserves the right to reject any or all of the bids without assigning any reason.
 - The agents and / or suppliers are not eligible to apply.
